

I have to agree with Mayleila and completely disagree with @diligentreader. This prep book is HORRIBLE in all ways possible that a prep book could. First off, the format is nothing like the ACT, even though one of the 3 "selling points" that the book boasts of on the back cover is that the format is "parallel to that of the ACT exam". Like Mayleila said, the REAL ACT has 5-7 questions per passage, and 7 passages total for the science section (3 passages of 5 questions, 3 passages of 6

questions, and one passage of 7 questions; you can find all this info on the wiki page for the ACT format). But this one only has 3 passages with around 15 questions each. Obviously, this is a GROSS disparity and reveals the deplorable LIE that McGraw Hill advertised on the very book cover. Furthermore, the answers in the book are often COMPLETELY INCORRECT. In the very first test (out of 12 tests in the book), for example, there was a "the graph best represents the data from which experiment?" guestion. The graph showed 3 lines that the solution explained represented all 3 objects of the experiment. However, the answer they had written in their solutions as correct was the only experiment that DIDN'T have 3 objects. In the solution, they explained that because the graph showed 3 data sets, the answer was naturally the experiment that had 4 data sets, and not either of the other two experiments that each had 3 data sets. BLASPHEMY.All in all, this book is complete. S***. Note, though, that this is coming from a Junior in high school who aims to get a 36 and go to Ivy League schools. I score very well on all other sections, but the science section always KILLS my score. So I was very excited to get this book when it came out. I actually preordered it, thinking that it would be helpful. But then I was started reading it, and the format was all wrong and I realize that I had been lied to, AND the answers are wrong. Back to the example I had provided in this review, I asked many people, teachers, friends who got 36s on the science section--they all agreed-- the answer was wrong. So now I am pissed af and this is the only time EVER that I have been compelled to write a review for something. I am a selfish person, and I view writing reviews as a waste of time, so the fact that I am writing this review speaks more than words. If I were you, I wouldn't waste my time or money. I would take the money that I would have used to purchase this book and I would buy a nice big cake, celebrating my wise investment in not buying this incorrect shit.UPDATE: I ultimately successfully raised my ACT science score this past March from a 31 to a 36! But this has absolutely nothing to do with this book. In fact, this book damaged me, wasted my studying time in both reading the book and having to correct the damage by going into meditation to "erase" any memories of my readings from this book. I would instead recommend a combination of practice practice practice (with the Big Red Book) and Barronâ Â™s ACT 36: 2nd edition: Aiming for the Perfect Score. Those two helped me a lot, and I would contribute my success fully to those two books. I wholly regret ever even touching this 500 ACT Science Questions book (false advertising, by the way; the questions are in no way $\tilde{A}\phi\hat{A}$ $\hat{A}\phi$ ACT $\tilde{A}\phi\hat{A}$ $\hat{A}\Phi$ questions), and I burned it in a bonfire.
