

This book is informative and easy to understand, and the authors are amusing as well. They added nice little tidbits of humor amidst the dry tone that academic works tend to have. The only complaint that I had was that they introduced the "TREAT" method, but weren't entirely clear (to my method of comprehension) what was required of it. They gave examples of the "TREAT" method on a single issue, but I was lost as far as "sub-TREAT" setup. I wouldn't recommend this book to anyone trying to learning legal writing skills without the guidance of a professor and/or attorney.

This book was required reading for my course. I found the writing to be generally good and helpful--if sometimes too wordy. However, I was rather annoyed by the formatting: alternating between black and blue text, a plethora of 'info boxes' inserted throughout the text, unnecessary charts and tables, etc. The core text did a good job of explaining things, but I often found myself skipping large chunks or entire pages because they interrupted the text that I needed to read with stuff that I didn't need. I can't say that I'd recommend this, but if it's required for a class then it's probably worth reading.
