Beyond that, developing a name you can trademark is one of the ways you can create a "monopoly" in a certain area. Sometimes there is just one best word that describes it. Why not search for one of those best words when you are dreaming up your next venture. You also want to know how to search to determine if anyone else is already using it in one of the other states.
