


The book was found

A Case of Redemption is an excellent book and I truly enjoyed it. I read Mr. Mitzner's first novel, A Conflict of Interest and was very anxious to read A Case of Redemption. Both books are excellent.

Although there is a slight comparison because they both involve lawyers, the story lines are completely different. As I read through A Case of Redemption, it moved along at a nice pace with a few twists and turns however I was blown away by the ending. What a turn of events that completely caught me unaware. The entire book is fantastic and I definitely recommend it.

It would be specious to say we have a new Grisham here, because truth be told, I like Mitzner better. Excellent writing and a gripping story. The twists and turns are unpredictable, and with the amount of reading I do, that's amazing. The characters are "real" and it's not easy to pull this off with the personalities he has chosen to write about. I enjoyed the ride, and was somewhat exhausted by the finish. You can't go wrong with this one, and I couldn't wait to get his first book. Outstanding!

This author has me reading his books about (gasp) Lawyers! The stories are intriguing, the writing is great, I don't even care that the subject matter is about my not absolutely favorite group of people. He shows them as people with a(nother) high-stress profession whose practitioners are people with whom you can have believable feelings of empathy. Who knew, Lawyers were people too (at least in books)? Great work....

I enjoyed reading A Case of Redemption. It follows the modern legal thriller formula: beautiful, successful characters wronged by stock antagonists, stylized judges, and the system, insights into the nuances of the legal system and the vagaries of human nature. The most impressive feature of A Case of Redemption is its plotting. The twists and turns lead the reader through an intriguing series of detours before reaching the conclusion. If I could talk to Mr. Minzer, I would ask him to be less didactic in explaining the legal system to his readers. It is better to show the legal system through dialogue than by instructing in separate paragraph. If Mr Minzer has tremendous potential as a writer of legal fiction.

I've read all three of Adam Mitzer's books and have been totally enthralled by each. Each lawyer/murder/mystery reels one in, making one think they know what's next, only to take a new twist or turn. I like that his emphasis is on the story and characters, not sensational nor graphic sex. Great stories.

As far as courtroom dramas go this was a good one. I wouldn't classify this work as a thriller, but it

was well written and with a good plot. I found myself always wanting to read more and that is a sign of a good book. Nice job. I would recommend this work to anyone, but especially to those interested in investigative works associated with courtroom drama.

Interesting characters. Twisted plot. Zinger of an ending. Highly recommended. I look forward to his next book. I'm always looking for great authors and this author is another great discovery to add to my collection.
