

It provides background, scientific research, and sufficient structure for treatment fidelity without limiting clinicians' ability to meet individual client/patient needs. What I would have liked--and this may be directed more toward the publisher than the authors--is more clarity on the reproducible handouts available. I found the handouts on trauma related to domestic violence and sexual abuse very good, as well as those on relaxation, affect, and cognition. What I was after* was material on trauma in general, useful for those whose trauma stemmed from neglect or abandonment, psychological abuse, or environmental causes, such as a car wreck or explosion.
