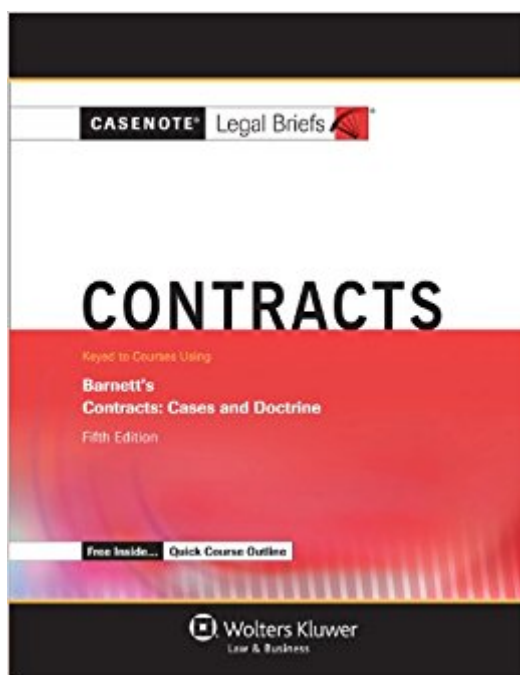

Very helpful companion to the textbook. The textbook itself is a very good one - clear, concise, and no-nonsense - but it's always good to have a brief book that's more top-down and put together just for the sake of really analyzing the cases in a structured, fat-trimming way. It's especially good to have this brief when you're running out of time for a proper class prep.

This book is great for reviewing right before class and will be helpful when studying for exams. Every case in the casebook is included. The briefs are unlikely to be able to get you through a cold call, but can be helpful if you have already done the work or if you didn't read and want to still be able to follow some of the class discussion.

It is helpful for your first weeks as a law student, or if English is your second language, it helps you to understand better every case. However, I wouldn't recommend to use this book on a daily basis instead of the casebook.

I liked having this while I read my cases because it's made for the casebook and it provided the proper rule of law that the casebook focused on.

Straight to the point. Brings out the issue, rule and analyses made in the case.

It helped sum up the cases pretty well. I wouldn't use it as a substitute for reading the text, but it certainly helps clarify what you read!
