

# **Synopsis**

Real Estate Math computations are also explained including calculations of Leases; Lot size, Commissions, Loan-to-Value, Discount Points, Qualifying Ratios, Amortized Mortgages, Adjustable Rate Mortgages, VA Entitlement, Profit/Loss, Prorated Closing Figures, State Transfer Taxes, Vacancy/Occupancy Rates, Appraisals, Capitalization Rate, Income Property, Capital Gains, Tax Millage, Homesteaded Assessments, and Straight-Line Depreciation.
