

In this newest edition of Environmental Politics and Policies, readers will find a comparable "framework" (the author's word) to the other editions as well as the same overall focus/spirit. However, there are also "significant editorial improvements" and a closer reading of current environment issues (xi). Likewise, professors (and other familiar with former editions of this text) will note refined organization and a meticulous culling of outdated material. Other valuable additions to the text address the impact of the Obama administration. For those new to this text or for professors looking to adopt a new textbook/supplementary textbook, do know that this can be used at multiple levels of study. Concepts such as "What is Environmental Justice?" are carefully and methodically unpacked (146). Perhaps most importantly, the author refrains from littering the text with technical jargon. It remains in entirely accessible language that an undergraduate can easily comprehend; however, it never talks down to the graduate student/professor nor does it engage in "hand holding." This is no minor feat. As a professor, I understand the value of captivating, well-edited, informative texts. So, I certainly appreciate this author's "commitment to material that is interesting as well as balanced and teachable -- in the end, a book that is both a good read and a fair read" (xiii). And, this finally comment is particularly potent. A text of this nature could be polarizing or even (in our current political climate) controversial. Instead, everything about this text reads as judicious as possible. This is one of the most closely edited, smart, balanced texts I have read on this topic. It is perfect for the classroom or even the casual reader. Highly recommended!

This is the 10th edition of this text. As a former professor, let me say that you may be able to get away with buying the cheaper 9th edition. That 3 year old edition will pretty much contain the same material except for the latest stuff on the Paris update to the Kyoto agreement. I guess it depends on how much you care about getting the current edition (and how much your professor likes to assign references that are only found in the current edition). If you are NOT enrolled in a class for which this is a required text, I would definitely go for an older edition, but you do need to recognize that I am a cheapskate.
