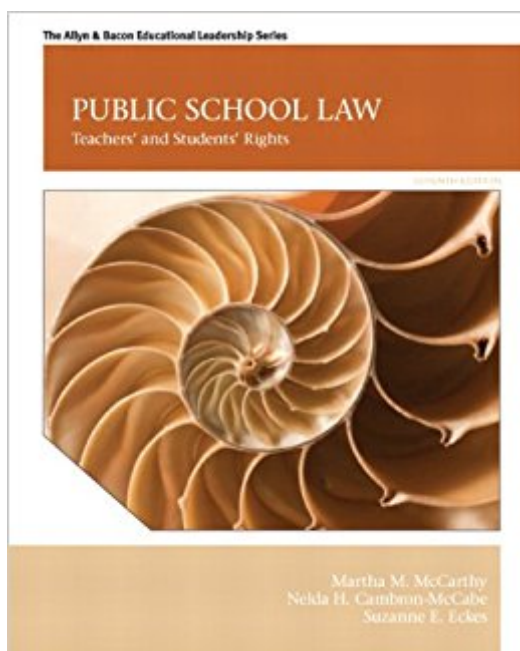

## Synopsis

With this seventh edition of *Public School Law: Teachers' and Students' Rights*, renowned authors Martha M. McCarthy, Nelda H. Cambron-McCabe, Suzanne E. For law students, it is primarily written for teachers, school administrators, and other public school personnel taking a school law course at the graduate and master's levels, there is not a greater, more comprehensive resource on the market today than *Public School Law, Seventh Edition*.

Martha McCarthy is Presidential Professor at Loyola Marymount University and Chancellor's Professor Emeritus at Indiana University where she teaches educational law and policy courses. She has written numerous books and articles, and has made frequent presentations on various school law topics at educational leadership programs with faculty members. She has served as President of the Education Law Association and the University Council for Educational Administration (UCEA), and Vice President for Division A of the American

Educational Research Association. Among her accolades, she received the Roald Campbell Lifetime Achievement Award from UCEA. Nelda Cambron-McCabe is Professor of Educational Leadership and Chair, Department of Educational Psychology at Miami University. Her teaching and research interests include public school law, leadership, and organizational learning. She has published extensively in these areas, including books and articles, as well as frequent presentations at conferences and to educators in the field. She has served as President of the Education Law Association and the American Education Finance Association, and has received a number of awards and honors for research and service contributions to education. Suzanne Eckes is an associate professor at Indiana University where she teaches and researches about education law. A prolific author, she has written over 70 articles on school legal issues, is a co-author on *Principals Teaching the Law* (Corwin, 2010), and a co-editor on the *Principal's Legal Handbook* (Education Law Association, in press) and *School Discipline and Safety* (Sage, in press). She has been invited to speak at several national and international venues about the legal rights of teachers and students, and has received several awards for her teaching and research accomplishments.

I'm just an average teacher trying to stay out of trouble. For example, I just KNOW that kid has a cell phone - can I ask him to empty his pockets? This book provides a lot of great information, presented in a way that a non-lawyer can understand and digest. The information is presented in a way that is relevant to both teachers and administrators. It's geared towards federal laws, with comments about when and how state laws may modify things. (I'd like to find a version of this book oriented specifically to my state, now!) The best part of this book was the end-chapter summaries, which made good, helpful generalizations. The biggest weakness of this book was the organization. I read it cover-to-cover, and I didn't notice any issues. However, later, when I wanted to go back to a specific topic, the index and table of contents weren't as helpful as they could have been. I eventually found the section I wanted, but it was more work than it should have been.

Just like in any career, the difference between the very good and the truly great is a bit of extra effort. I'm certain every teacher can benefit from this book. *Public School Law* explains the legal foundations of school boards and administrative bodies. The section on student records was enlightening. I learned also about the legal ramifications of rules imposed on students including attendance requirements, hairstyle and attire. This is not a difficult book to read. I recommend it for all educators.

I had to purchase this for one of my teacher credentialing classes. It was dense at times, but I like that at the end of each chapter they have a summary of the main points. It made reading it a lot easier. The only thing I didn't like was the price. I don't really see why it's so expensive.

This book has been set up perfectly! I am amazed that I graduated with a degree in education and was never required to take a course covering this material. Every future or current teacher needs to have a copy on hand and should probably read it before entering the classroom.
