

Those books are way more expensive, and the wording of them was like reading the terms of conditions of stuff you don't need to know at all. I hated the format of the books so much, which is why I started looking for more materials in the first place.My girlfriend was studying to take her P&C license too, and also used this book as her primary method of studying. We both passed on our first attempt, myself receiving a 69% and she had 71% (CA lowered passing score to 60%) so definitely a thumbs up. If we could do it over again, we would not purchase any other books, other than this one.The practice exams that come with this book are fantastic.

I bought this book mainly for the exam simulator which is no longer supported by current operating system nor the publisher. But, I ended up still giving this 4 stars and here's why?...
