

KiKi Canniff is a retired tax consultant who is also the author of the Annual Tax Mess Organizer System. She has helped train tax preparers for a national tax chain, managed a tax office, and taught hundreds of self-employed people how to keep audit-proof records.

I found this book really helpful. She makes it easy to set up a simple system that will eliminate most of the headaches at tax time. Her explanations are clear enough that anyone can understand them.

The author presents a no-nonsense method for sorting through receipts, expenses, tax calculations, etc. for the sole proprietor. More complex issues are referred to a "tax professional" by the author, but even so, a person who has a partnership or other more complex business entity could still benefit from organizing things before they visit the tax guy.
