If this book is intended as a defense of Mr. Skakel, it should be shortened and better organized--the defense was buried in a lot of vitriol and interesting, but irrelevant information. Maybe start with the alibi, then move right into the other suspects for the SODDI defense, instead of burying this information in the last few chapters. If any of the information in this book is true, then Mr. Skakel should be granted a new trial. If the real killers are still out there, they need to be prosecuted as they would have added a new victim to their debit sheet. Note I say "if". This book comes from an extremely biased viewpoint. I understand that being related to the Kennedys, who hare viewed as having 'got away with' their fair share of crimes, would be a considerable handicap as a defendant. And certainly, Mr. Skakel, who is not a blood relative of the Kennedy family, has been branded as the Kennedy Cousin, to his detriment. However, it's hard to claim family disinterest when you write a book. The viewpoint of the author would be better served by a more neutral voice. As an attorney, the author could have also illustrated his points with quotes from court transcripts and police reports instead of descriptions of testimony and paraphrasing. If he is correct, then a terrible injustice has been done. I assume the release of this book on sale is not serendipitous but reflects the request for reconsideration launched last month.
