The forms might be helpful for practitioners, though I would imagine most have their own database of forms. Statutes are available online for free and won't become obsolete within the year. The cover is flimsy and I guess they went for premium glossy paper instead of the normal tissue paper most supplements are made out of, but as a result it's deceptively heavy. The spacing in this is awful-- it's at least 1.5 spacing, but in such a way it's difficult to read. A single section of a statute can span over 3 pages, and especially where the statutes are more like lists, having it all on one page would be easier to scan through than having to flip through the pages, not to mention it'd be less of a hassle to lug around.
